

Print Passport Applications

IMPORTANT NOTICE: Beginning February 1, 2004, all minors applying for passports must appear in person. The DS-11: Application for Pasport below does not reflect the new requirement. New DS-11's will be available soon. [Click here for more information on the new requirement.](#)

I have the required software and paper.

DS-11 and DS-82 application forms both have 4 pages. Pages 1 and 2 provide information for the applicant and are not for submission. Page 3 requires information to be completed by the applicant, and although page 4 requires no information from the applicant, it does contain official legal statements and is required as part of the application form. Pages 1,2, and 4 should be read before completing page 3. Your application for submission must be printed pages 3 and 4. Your application will not be accepted without both these pages.

The following forms are available for printing. Failure to use the correct form will result in a delay in the issuance of your passport:

DS-11: Application for Passport

Pages 3 and 4 of this form must be presented and signed in person at an authorized passport acceptance facility.

You must use this form IF:

1. You have never had a US passport or
2. You are under age 16 or
3. Your most recent passport was issued more than 15 years ago or
4. Your most recent passport was lost or stolen. (If you are applying because your most recent passport was lost or stolen, you will also need to submit Form DS-64 listed below.)

Please follow the instructions on pages 1 and 2. Print and complete page 3, and print and read page 4 carefully before appearing with pages 3 and 4 to apply for your passport.

DS-82: Application For Passport By Mail

(For Renewals Only) This form should be used for renewing a previously issued US passport by mail at anytime **OR** in person at a Regional Passport Agency if you are traveling internationally, or need your passport for foreign visas, with 14 days. [For a list of Regional Passport Agencies, including their addresses and automated appointment system telephone numbers, please click here.](#) There are 4 criteria for using this form. Please use the following checklist to see if you are eligible to apply with a DS-82:

1. I can submit my most recent passport **AND**
2. I was at least 16 years old when my most recent passport was issued **AND**
3. I was issued my most recent passport in the last 15 years **AND**
4. I use the same name as on my most recent passport or since my passport was issued, I have had my named changed by marriage or court order and can submit proper documentation to reflect my name-change.

If you answered NO to any of the 4 statements above...STOP! You cannot use Form DS-82! You must apply on a DS-11.

DS-19: Passport Amendment/Validation Application

This form should be used for amending a previously issued US passport by mail at anytime **OR** in person at a Regional Passport Agency if you are traveling internationally, or need your passport for foreign visas, with 14 days. For a list of Regional Passport Agencies, including their addresses and automated appointment system telephone numbers, please click here.

This form should be used:

- Whenever there is a change in the printed information (e.g., name-change) after your passport was printed
- To extend the validity of certain previously limited passports; or
- To add visa pages.

Please follow the instructions on page 2 of the form carefully. Print and complete page 1 and print and read page 2 carefully. When amending by mail, submit pages 1 and 2 to:

DS-64: Statement Regarding Lost Or Stolen Passport

This form should be submitted along with the DS-11 Application for Passport and brought with you when you go in person to apply for a new passport if your previous passport has been lost or stolen.

DS-3053: Statement of Consent - Issuance of a Passport to a Minor Under Age 14

This form should be submitted, along with the DS-11 Application for Passport, for minors under age 14 as evidence of parental permission if:

- You are a non-applying parent or guardian consenting to passport issuance for your child, or
- You are an applying parent or guardian, and the written consent of the non-applying parent or guardian cannot be obtained.

In advance of your departure, check visa requirements with consular officials of the countries you will be visiting.

SPECIAL REQUIREMENTS FOR CHILDREN UNDER AGE 14 (As directed by Public Law 106-119.)

To submit an application for a child under age 14 both parents or the child's legal guardian(s) must appear and present all of the following:

- Evidence of child's U.S. citizenship,
- Evidence of child's relationship to parents or guardian(s), AND
- Parental identification

IF ONLY ONE PARENT APPEARS YOU MUST ALSO SUBMIT ONE OF THE FOLLOWING:

- Second parent's written statement consenting to passport issuance for the child,
- Primary evidence of sole authority to apply, OR
- A written statement (made under penalty of perjury) explaining the second parent's unavailability.

FIRST TIME APPLICANTS:

Please complete and submit this application in person. Each application must be accompanied by:

- (1) PROOF OF U.S. CITIZENSHIP
- (2) PROOF OF IDENTITY
- (3) TWO PHOTOGRAPHS, AND
- (4) FEES (as explained on reverse) to one of the following acceptance agents: a clerk of a Federal or State court of record or a judge or clerk of a probate court accepting applications, a designated municipal or county official, a designated postal employee at an authorized post office, an agent at a Passport Agency in Boston, Chicago, Honolulu, Houston, Los Angeles, Miami, New Orleans, New York, Norwalk CT, Philadelphia, San Francisco, Seattle, or Washington, DC, or a U.S. consular official at a U.S. Embassy or Consulate, if abroad. PLEASE DETACH AND RETAIN THIS INSTRUCTION SHEET FOR YOUR RECORDS

1. PROOF OF U.S. CITIZENSHIP

- a. **APPLICANTS BORN IN THE UNITED STATES:** Submit previous U.S. passport or certified birth certificate. A birth certificate must include your given name and surname, date and place of birth, date the birth record was filed, and the seal or other certification of the official custodian of such records.
- (1) If the birth certificate was filed more than 1 year after the birth: It is acceptable if it is supported by evidence described in the next paragraph.
- (2) If no birth record exists: Submit registrar's notice to that effect. Also submit an early baptismal or circumcision certificate, hospital birth record, early census, school, or family Bible records, newspaper or insurance files, or notarized affidavits of persons having knowledge of your birth (preferably in addition to at least one record listed above). Evidence should include your given name and surname, date and place of birth, and seal or other certification of the issuing office (if customary) and signature of issuing official.
- b. **APPLICANTS BORN OUTSIDE THE UNITED STATES:** Submit a previous U.S. passport, Certificate of Naturalization, Certificate of Citizenship, Consular Report of Birth Abroad, or evidence described below.
- (1) If You Claim Citizenship Through Naturalization of Parent(s): Submit the Certificate(s) of Naturalization of your parent(s), your foreign birth certificate, and proof of your admission to the United States for permanent residence.
- (2) If You Claim Citizenship Through Birth Abroad to One U.S. Citizen Parent: Submit a Consular Report of Birth (Form FS-240), Certification of Birth (Form DS-1350 or FS-545), or your foreign birth certificate, proof of citizenship of your parent, and an affidavit of your U.S. citizen parent(s) showing all periods and places of residence or physical presence in the United States and abroad before your birth.
- (3) If You Claim Citizenship Through Birth Abroad to Two U.S. Citizen Parents: Submit a Consular Report of Birth (Form FS-240), Certification of Birth (Form DS-1350 or FS-545), or your foreign birth certificate, parent's marriage certificate, proof of citizenship of your parents and an affidavit of your U.S. citizen parent(s) showing all periods and places of residence or physical presence in the United States and abroad before your birth.
- (4) If You Claim Citizenship Through Adoption by a U.S. Citizen Parent(s): Submit evidence of your permanent residence status, full and final adoption, and your U.S. citizen parent(s) evidence of legal and physical custody.

2. PROOF OF IDENTITY

You must establish your identity to the acceptance agent. You may submit items such as the following containing your signature AND physical description or photograph that is a good likeness of you: previous U.S. passport, Certificate of Naturalization, Certificate of Citizenship, driver's license (not temporary or learner's license), or government (Federal, State, municipal) employee identification card or pass. Temporary or altered documents are not acceptable

IF YOU CANNOT PROVE YOUR IDENTITY as stated above, you must appear with an IDENTIFYING WITNESS who is a U.S. Citizen or permanent resident alien who has known you for at least 2 years. Your witness must prove his or her identity and complete and sign an Affidavit of Identifying Witness (Form DS-71) before the acceptance agent. You must also submit some identification of your own.

3. TWO PHOTOGRAPHS

Submit two identical photographs of you alone, sufficiently recent to be a good likeness of you (normally taken within the last 6 months), and 2 x 2 inches in size. The image size measured from the bottom of the chin to the top of the head (including hair) should not be less than 1 inch and not more than 1-3/8 inches. Photographs must be clear, front view, full face, taken in normal street attire without a hat or dark glasses, and printed on thin paper with a plain light (white or off-white) background. They may be in color or black and white. They must be capable of withstanding a mounting temperature of 225° Fahrenheit (107° Celsius). Photographs retouched so that your appearance is changed are unacceptable. Snapshots, most vending machine prints, and magazine or full-length photographs are unacceptable. Digitized photos must meet the previously stated qualifications and will be accepted for use at the discretion of Passport Services. (Visit our website for details)

4. FEES

- a. If you are 16 years of age or older: The passport processing fee is \$55. In addition, a fee of \$30 is charged for the execution of the application. Your passport will be valid for 10 years from the date of issue except where limited by the Secretary of State to a shorter period.
- b. If you are 15 years of age or younger: The passport processing fee is \$40. In addition, a fee of \$30 is charged for the execution of the application. Your passport will be valid for 5 years from the date of issue except where limited by the Secretary of State to a shorter period.

BY LAW, THE PASSPORT PROCESSING AND EXECUTION FEES ARE NON-REFUNDABLE

- The passport processing and execution fees may be paid in one of the following forms: Checks (personal, certified, traveler's), major credit card (Visa, Master Card, American Express, and Discover), bank draft or cashier's check, money order (U.S. Postal, international, currency exchange), or if abroad, the foreign currency equivalent, or a check drawn on a U.S. bank. All fees should be payable to the "U.S. Department of State" (except the \$30 execution fee when applying at a designated acceptance facility), or if abroad, the appropriate Embassy or Consulate. NOTE: Some designated acceptance facilities do not accept credit cards as a form of payment.
- For faster processing, you may request Expedited Service. Expedited requests will be processed in three workdays from receipt at a Passport Agency. The additional fee for expedited service is \$60. Expedited Service is available only in the United States.
- If you desire SPECIAL POSTAGE SERVICE (overnight mail, special delivery, etc.), include the appropriate postage fee with your payment.
- An additional \$45 fee will be charged when, upon your request, the U.S. Department of State verifies issuance of a previous U.S. passport or Consular Report of Birth Abroad because you are unable to submit evidence of U.S. citizenship.
- For applicants with U.S. Government or military authorization for no-fee passports no fees are charged, except the execution fee when applying at a designated acceptance facility.

Any applicant who fails to provide the required information is subject to a \$500 penalty enforced by the IRS. All questions on this matter should be referred to the nearest IRS office.

ROUTINE USES: The information solicited on this form may be made available as a routine use to other government agencies, to assist the U.S. Department of State in adjudicating passport applications, and for law enforcement and administration purposes. It may also be disclosed pursuant to court order. The information may be made available to foreign government agencies to fulfill passport control and immigration duties or to investigate or prosecute violations of law. The information may also be made available to private U.S. citizen 'wardens' designated by U.S. Embassies and Consulates.

Failure to provide the information requested on this form may result in the denial of a United States passport, related document, or service to the individual seeking such passport, document, or service.
